This is my opinion to the consultation paper for Hong Kong's health financing arrangement.

The concerns about ageing population and rising medical costs are real and must be dealt with. But I have not found any wordings about cost cutting in the consultation papers.

Being a responsible government, it should look into itself and find every possible way to cut cost before stretching the hands into the people's pockets. Before your department comes up with strings of suggestions on how to cut cost, none of the proposed financing plans seems wise. Without a sound way on how to spend public money wisely, no budget in the world is sufficient to cover the rising cost brought by ageing population and expensive medicines. This is not only Hong Kong's problem.
